Greenlandic handicraft – more than mere souvenirs

CITES (Washington Convention) CITES is the acronym for "Convention on International Trade in Endangered Species of Wild Flora and Fauna".

The Washington Convention makes it possible to track the degree of trade in certain endangered or threatened animal species. With your CITES permit you are therefore contributing to securing a sustainable future for the respective animal populations.

The Washington Convention is, among other things, known from campaigns against trade in tigers, turtles, other exotic animal species and ivory.

The Convention has been signed by more than 170 countries and protects the world's many threatened and endangered plant and animal species by regulating the international trade in wildlife species. There are more than 4,800 animal species and 25,000 plant species listed in CITES. About 30 of these animal species and a few of the plant species occur in Greenland.



The CITES certificate is more than simply a customs document. It is also a guarantee that the goods originate from species that can legally be hunted in Greenland.

Fin whale, Bowhead whale, Sperm whale, Humpback whale, Minke whale from East Greenland, Narwhal, Killer Whale, Pilot Whale, Porpoise, Polar bear and all prey birds are not allowed to be exported by tourists.



As a tourist you are allowed to export products of the following animals if you have a CITES permit for your purchase:

- -Walrus
- -Beluga Whale
- -Minke Whale from West Greenland

About the CITES permit The CITES permit looks like this:



It is important that you receive the front page, the red copy and the blue copy.

The CITES permit is only valid for exporting items for *personal use*. The items must be transported in your personal luggage.

If the shop itself does not complete and issue you with the CITES permit, request one in the shop.

No permit

If you haven't received a CITES permit for the handicraft items you have bought on the street or in a shop, you can contact the Greenland CITES Management Authority and ask for a permit.

Export of walrus products

Please note that it's not allowed to send items of walrus to countries in the EU by mail. Items of walrus can only be imported to the EU as personal items carried on the body or in the luggage.

REMEMBER that illegal export or failure to obtain a permit can result in confiscation of goods and a fine.
